


# Train Order



His response of offering to switch Toledo to the 2013 Convention was rejected by a membership vote. Division One's offer of switching to 2015 was not addressed in Watson's message. Superintendent Lux will continue the discussion with the regional Board. But 2013 is not an option for Division One.
